Briefly describe the program proposal (new or change) and provide a justification:

We would like to clarify the wording in the catalog and add verbiage to CMS to clarify the GPA requirements for graduation from the CSAD program. Currently, the wording in CMS is vague and confusing.

In CMS, we would like the following statement on the Degree Requirements page to align with the same catalog language: "In addition to obtaining a 2.0 in the overall 52-55 unit major, a student must achieve an overall average 2.5 GPA in the 40 units of required CSAD major coursework in order to graduate with a Bachelor of Science Degree in Communication Sciences and Disorders. In order to achieve these GPAs, students may repeat courses for which grades of C- or below were earned, contingent upon their eligibility to do so under the campus policy on repeating courses. Repeated course grades will either be forgiven or averaged with the new grade according to the campus policy on repeating courses. Students must complete the major prerequisites before beginning courses in Communication Science and Disorders."

CSAD 148: Research in Speech - Language Pathology and Audiology is taken by CSAD students in Spring of senior year and we are changing it so that it will be taken in Spring of junior year. This program modification will better prepare students for reading research when taking senior level courses. CSAD 148 is being added as a prerequisite to several senior level classes a result of changing the position of CSAD 148 in our bachelor's of science curriculum.

As CHDV 30 is no longer offered, we have changed the prerequisite to read CHAD 30, the new course in its place.
