Justification for course proposal:

Students in Communication Sciences and Disorders complete premajor coursework consisting of courses in introduction to psychology (PSYC 2 or equivalent), introduction to statistics (STAT 1 or equivalent), human development (across the lifespan; CHAD30 or equivalent) and american sign language (DEAF 51 or equivalent) prior to enrolling in the Fall semester, junior year courses (CSAD 110, 111, 112). Our CSAD undergraduate program is a lock-step program consisting of 4 semesters of undergraduate coursework. Premajor courses total 12 units of coursework which shows students' significant dedication to pursuing CSAD prior to entering junior year. There is currently no coursework that provides students with an upper division option that provides an overview of the communicative disorders field while also providing GE units. Our department is creating this course to allow students interested in the communication sciences and disorders major with the ability to take one introductory class to learn about the field prior to completing premajor requirements. It is also being created to provide students in the meta major of health sciences with an option to learn about CSAD and give them upper division units. This course requires students to complete writing assignments of 1500 words across the semester and receive multiple opportunities for feedback. We are choosing to not make this a required course for CSAD majors as students who take CSAD 110, 111, and 112 are generally committed CSAD majors who will not require these additional units to graduate.

This survey course serves as an introduction to the field of communication sciences and disorders (CSAD; speech-language pathology and audiology) and serves three general groups of students: (1) undergraduate majors in CSAD, (2) undergraduate students considering a major in CSAD, and (3) students from related fields, such as education, nursing, health sciences, etc. Through the course, students will gain a broad understanding of clinical work and research in the field of communication sciences and disorders.
