Justification for course proposal:

This course builds on existing major courses by focusing on California-specific policymaking to prepare students for employment with state agencies engaged in efforts around the Master Plan for Aging. With the recent development and implementation of California's Master Plan for Aging, the state has created new ways to serve older adults. The role of advocacy throughout the service continuum (legislative, community-based, person centered) has expanded the knowledge needs for working in aging services. This course is designed to prepare students with knowledge of state structures, procedures and opportunities for development of innovative practices. This course offers a population-specific view so that students can understand why policy, programs and services are changing to meet the needs of underserved constituencies. This course will be paired and crosslisted with GERO 225.

This course examines California's state programs, services, and funding streams that support low-income older adults and persons with disabilities. It is focused on addressing equity, parity, funding and access. Students will be introduced to California's innovative Master Plan for Aging. Through studying past shortfalls and new approaches, this course will inform a new and diverse workforce in order to serve historically underserved communities, including BIPOC, Latinx, API, and LGBTQ+.
