Justification for course proposal:

This course hasn't been formally updated since it was first proposed in 2008, although both LGBTQ politics and the course content has evolved substantially over the past 14 years. The course title is being updated from "Gay and Lesbian Politics" to "LGBTQ Politics" to make it more inclusive and to better reflect current course topics, which include substantial discussion of the transgender community. The course description and learning objectives are also changing accordingly. Lastly, the POLS 1 or POLS 150 prerequisite is being dropped. It is not essential to have for this course, and it has sometimes hindered new transfer students from registering whose POLS 1/150 courses at other schools have not posted yet.

This course provides an in-depth examination of the politics and history of the lesbian, gay, bisexual, transgender, and queer (LGBTQ) communities in the United States. Particular emphasis will be placed on current American political issues impacting the LGBTQ community.
