This is a program change in which certain courses have been renamed, redesignated as to which semesters they will be offered, and the nature of one course, Deaf 165 has been clarified in order to both offer students greater options when planning for their course of study. This program change does not represent an increase in programmatic credit units. This change was needed since under the previous structure, both students and the university were unclear as to whether students might receive credit for taking the different iterations of Deaf 165.
