Briefly describe the program proposal (new or change) and provide a justification:

February 13, 2022

We are elevating the Health Care Administration Concentration, currently known as B.S. in Public Health (Health Care Administration), to a B.S. in Health Services Administration. The purpose of the elevation is to align our program with the requirements of accrediting bodies in health administration and close some curricular gaps. To fill these gaps by adding courses and removing content that duplicates learning objectives, the program will no longer meet the 51% shared curriculum requirement to be a concentration in the Public Health Program.

Furthermore, the current program's learning objectives and curriculum better align with the title Health Services Administration according to the following CIP code definition: "A program that focuses on the application of policy analysis, public administration, business management, and communications to the planning and management of health services delivery systems in the public and private sectors, and prepares individuals to function as health services administrators and managers. Includes instruction in health systems planning, public health organization and management, public health policy formulation and analysis, finance, business and operations management, economics of health care, organizational and health communications, marketing, human resources management, and public health law and regulations."

We have previously revised two courses in the major (one required and one elective), which are already updated in the current catalog: We have revised PUBH 118 from Community Health to Introduction to Public Health. We have done so because it is a core class for all three public health concentrations (Community Health Education, Healthcare Administration, and Occupational Health and Safety). The revised course, Introduction to Public Health, provides a stronger foundation in public health more appropriate for for all three concentrations than the current course with a focus solely on Community Health.

We have are adding a newly revised course to the elective options. PUBH 124 has been updated to be Public Health Ethics and is now being offered as an option for the Ethical Issues Courses in the major.

We are not proposing any changes to the objectives of the degree program.

This is a program elevation with minor course changes made. The changes to the Smart Planner Roadmap are considerate of GE requirements, transfer students, and students' ability to graduate in four-years.

Program Description

The academic area of study in Health Services Administration in the Department of Public Health is part of the College of Health and Human Services. Students pursue a Health Services Administration degree to gain specialization and job skills applicable to the management and administration, research, human resources, and policies in the context of healthcare services. The faculty supports the idea of focused academic preparation such that Health Services Administration BS graduates will have job appeal in their chosen professional field and are competitive applicants for postbaccalaureate/graduate programs.

Students can expect to be involved both in class and field experiences, to prepare students to for management and administrative roles in public, not-for-profit, and private health care settings. Graduates from this program will gain skills in marketing, finance, Human Resources, working knowledge of healthcare and health services operations, information systems, statistical analysis, quality improvement, and ethics. Furthermore, this program will prepare students to enter the workforce with the ability to engage with diverse populations in the role of managers and administrators of health services.

The Health Services Administration BS program at Sacramento State is a highly sought-after degree. Due to the large number of applications, the program has a pre-major status. Students wishing to become Health Services Administration majors must complete a series of required lower division courses in order to be eligible to declare the major. Students should check the Department website

Note: Students graduating with a BS in Health Services Administration will not be subject to the University's Foreign Language Graduation Requirement. Students who change major may be subject to the University's Foreign Language Graduation Requirement.

Admission Requirements: Course prerequisites and other criteria for admission of students to the degree major program, and for their continuation in it.

Pre-Major Requirements

Freshman or transfer students interested in the Health Services Administration Major are admitted as Pre-Major Health Services Administration students.

To change to a Health Services Administration Major, all students are required to complete the follow grade and course requirements and submit a Declaration of Major form to the Public Health Department along with transcript copies:

- 1. An overall GPA of 2.5 and be in good academic standing.
- 2. Completion of the Pre-Major Required Courses with a "C" or better in each course. Only first or second attempts will be considered.
- 3. Completion of more than 45 units.

Additional Information

Repeat Policy: Health Services Administration Majors can only repeat Health Services Administration courses one time if they receive less than a "C." Students must meet with their academic advisor before petitioning the department to repeat the course. Refer to the Repeat Policy section of the Sacramento State Catalog for additional information.

Credit by Examination: A student who seeks course credit by examination is to enroll in the course to be challenged. No course may be challenged after the first two weeks of the semester. The instructor of the course will conduct an assessment of the student's readiness for the challenge for credit examination. Refer to Credit by Examination section of the Sacramento State Catalog.

Advising: It will be necessary to work very closely with an advisor to complete the BS degree in a timely manner. Therefore, the faculty strongly recommends that all Health Services Administration students consult with an advisor prior to enrollment for any course. This procedure should be followed each semester.
