Briefly describe the program proposal (new or change) and provide a justification:

The Philosophy Minor currently requires 18 units, 9 of which must be specific lower-division courses, and 9 of which must be upper-division. We believe the requirement to take specific lower-division courses is too restrictive and may be an unnecessary obstacle to timely graduation. Philosophy has many upper-division GE courses that have no prerequisites, and we would like students to be able to use more than 3 of them in satisfaction of the minor if they so desire. Consequently, we are revising the minor to eliminate the lower-division requirements. The minor will now simply require 18 units, 9 of which must be upper-division.
