The proposed course teaches technical and critical skills needed to address the growing demand for qualified Spanish-English medical interpreters. In addition to meeting community needs, the course increases career opportunities for bilingual speakers of Spanish and English by fulfilling the prerequisite for certification through the National Board of Certification for Medical Interpreters. The course adds an option for students pursuing the Spanish major, Spanish minor, and HEALS certificate (Form B expected Fall 2023) who wish to focus on interpreting.
