Briefly describe the program proposal (new or change) and provide a justification:

Due to EO 1071, the Family and Consumer Sciences degrees have change from being concentrations under one umbrella to stand alone degrees. This makes the catalog description and curriculum requirements for the minor unclear. This proposal clears up that confusion and makes some changes that will align it with programmatic changes proposed for the BS Family and Consumer Sciences (FACS).

This proposal for a Minor in FACS provides a breadth of knowledge across Nutrition and Food, Family Studies and Human Development, Fashion Merchandising and Management, and Consumer Sciences. Because the field of Family and Consumer Sciences encompasses the essentiality of the human requirement for food, clothing, habitat/shelter, family, and financial and resource management, this minor will help students apply elective units toward basic life skills. Additionally, the minor provides a breadth of options that could assist in preparing for the California Subject Examinations for Teachers to become a credentialed teacher in Family and Consumer Sciences/Home Economics. Students from any major are eligible to take independently study topics of this examination and later pursue a teaching credential, but this minor provides instruction and hands on learning at the same time students are meeting other graduation requirements.

The changes in courses are as follows: Delete FACS 50 because this course subject code has changed to FSHD 50. Add FSHD 50 as the introductory course to the Family area to replace FACS 50. Add FASH 30 as the introductory course to the Fashion area. NUFD 10 is the introductory course to the Nutrition area. These require that students complete at least one gateway course in the Family and Consumer Sciences areas.

Rather than selecting any 21 units among no-longer-existing concentrations, electives have been divided between lower division (up to 9 units) and upper division (minimum of 12 units). This offers students flexibility based on the content of their major while providing breadth across the minor. With the requirements in the majors for Nutrition and Food, Family Studies and Human Development, Fashion Merchandising and Management in mind, a select variety of courses from each program were included to make it possible for the minor to complement these majors without requiring more than 120 units to graduate.

Different from the BS in FACS major, the minor can be earned without the requirement that all courses be passed with a C- or better. However, it will be explained that a minimum grade of "C-" for all courses (regardless of prerequisite status) may be required of students planning to seek admission into Sacramento State's or other teacher preparation programs.

We propose that the courses applied to the minor not overlap (double dip) with requirements in a major. We are proposing this so that it would not be possible for students in the Family Studies and Human Development, Fashion Merchandising and Management or Nutrition and Food majors to earn a minor by completing as little as 6 units. Because all but a couple courses proposed for the minor are requirements in a major we feel that electives in a major could double dip with the minor.

If required courses are counted toward the minor, the following major/minors would be able to earn the minor with only the following additional units:

BS FASH 12 units

BS FSHD 9 units

BS NUFD 6 units

The minor in Family and Consumer Sciences provides basic life skills across Nutrition and Food, Family Studies and Human Development, Fashion Merchandising and Management and/or Consumer Sciences. These fields encompass the essentiality of the human requirement for food, clothing, habitat/shelter, family, and resource management. The minor in Family and Consumer Sciences also provides a foundation of knowledge needed to pass the California Subject Examinations for Teaching (CSET) to become eligible for a teaching credential in Family and Consumer Sciences/Home Economics.
