In order to comply with EO 1071, our previously existing NUFD concentration in the FACS Department was proposed as a stand-alone degree program, "BS in Nutrition and Food." This was approved and became effective in fall 2019. Moreover, the evolution proposal of separating NUFD from the Family and Consumer Sciences was recommended unanimously by the Faculty Senate and approved by the President as of October 2022. As a result of this change, we are proposing a new course, NUFD 195 Internship, which is needed in preparation for the upcoming new department, Nutrition, Food & Dietetics (NUFD). Internship is a required course for the NUFD Grocery Management Certificate and also provides an opportunity for NUFD students to gain experience for career readiness.
