The primary purpose of this proposal is to provide this foundational knowledge to students while completing their degree at Sac State.

This course will initially be cross-listed as RPTA 6/HLSC 6. The purpose for the cross-listing is two-fold. First, it will allow students from multiple majors to take the course (HLSC 6). Second, it will ensure that seats are available to the RPTA majors who must take this course as a requirement in their curriculum (RPTA 6).

This proposal does not preclude other departments from developing and cross-listing their own version of course (e.g., KINS 6, CSAD 6, PUBH 6) in the future.
