Briefly describe the program proposal (new or change) and provide a justification:

We are proposing changes to our BS NUFD elective options.

We want to add two new elective options (NUFD 122 and 111) and delete one option (NUFD 112).

NUFD 122 (Social Media for Nutrition Communication) and NUFD 111 (Grocery Procurement & Merchandising) are new courses that have already undergone curriculum approval and are in the schedule for the 23/24 academic year so the next step is to add them to the elective options in the major. These courses will be offered alternatively with other NUFD electives so they won't have fiscal or programmatic impact. Both of these electives are relevant to the NUFD major and reflective of career opportunities with increased use of social media in nutrition education (NUFD 122) and increased career opportunities within the food retail sector (NUFD 111).

Since there is now a robust offering of electives (NUFD 111, 116, 117, 120, 121 & 122), we are proposing to delete NUFD 112, Current Topics in Nutritional Sciences, as an option. This course overlaps with content from other required major courses including foundational nutrition concepts covered in NUFD 10 and 113; therefore, students would benefit from taking other elective options to increase competency and career readiness.

Lastly, two updates to the GE Requirements section have been made to align with the major courses, NUFD 114 (area C) and PSYC 2(area D) with the addition of footnote 2 "Required in Major; also satisfies GE." These are not new GE courses but have not been updated in this table.
