#### Justification for course proposal:

EDC 477 is being proposed as a required course within the Certificate in Play Therapy, which is designed to provide students with the supervision needed to earn the RPT and SB-RPT credentials. This course can be taken concurrently with practicum and internship courses in the M.S. Counseling program or alongside earning post-graduate hours in the field for those who have already earned a master's degree in counseling. Students will participate in both group and individual supervision, and may repeat the course to earn the required supervision hours to apply for the RPT and SB-RPT credentials. The M.S. Counseling program has a tenured faculty member with an RPT-S who is able to provide supervision and teach this course. The cohort sequence within the M.S. Counseling program allows students to add the Certificate in Play Therapy to their program of study without increasing their tuition or time to degree. The course will also be offered through CCE to community members who want to become eligible for the RPT and SB-RPT credentials and already possess a master's degree in counseling and mental health license or associate registration, or Pupil Personnel Services Credential.

EDC 477 is a 1-unit advanced counseling course designed to provide students with specialized supervision in play therapy from a faculty member who possesses the RPT-S credential. This course is intended to be taken concurrently with practicum, internship, or while earning post-graduate hours in the field. Students will participate in a weekly one-hour supervision group, as well as receive tri-weekly individual supervision to fulfill the play therapy supervision requirement for the Registered Play Therapist and/or School Based-Registered Play Therapist credentials.
