Justification for course proposal:

The focus of 197 has evolved over time. It has become a 2D animation course rather than a course dealing with digital imaging and multimedia. The original Course/Catalog Description no longer accurately reflects the actual course content, and the content that is being taught needs to be broken out into two separate 2D animation courses with different approaches to time, composition, and content development. One will have a narrative, storytelling focus, and the other has an experimental, non-narrative focus so that these different trajectories can be covered in depth at the intermediate level. The first of these is New Media: 2D Character Animation, employing narrative approaches to 2D animation.
