#### Justification for course proposal:

This course is critical to meet the need for school audiometrist certification for Northern California school nurses. There is an ongoing shortage of school nurses throughout the state. Many of the school nurses currently enrolled in the School Nurse Credential program at Sacramento State have shared that they are understaffed and their districts have open positions they are trying to fill. There are currently 5 school nurse credential programs in the state of California. At Sacramento State, we accept up to 100 new applicants to our program each year. Every one of the school nurses must have completed their school audiometrist certification prior to applying for their cleared School Nurse Services Credential at the conclusion of the program.

Most districts require that newly hired school nurses (practicing under a preliminary credential) obtain audiometry certification within the first year of hire. Currently, there are two available programs in the CSU system, at Fresno State and CSU, San Bernardino. School nurses currently enrolled in the school nurse credential program have shared that, at the time they were seeking their audiometry certification, some were unable to get into the program at Fresno State and were placed on a waiting list. All nurses who applied at San Bernardino were able to get into the program. However, the classes were large, with approximately 80 students, and were 100% on-line, with skills performed via on-line simulation. While this is convenient for many, it may not suit the needs of all learners, as many prefer hands on opportunities for practicing and performing skills.

The Audiometry and Hearing Screening course is tailored to meet the needs of school nurses seeking their school audiometry certification. Having the majority of the course offered on-line will make it highly accessible for working school nurses. Offering the practical portion of the course via a weekend in-person session ensures that school nurses are able to practice skills and develop proficiency using the same equipment and procedures they will utilize with students in their schools. The in-person portion also allows for a networking opportunity with other new school nurses; something we know is of great value, based on feedback we've received from candidates in our School Nurse Credential Program.

Covers the nature of sound, the anatomy and physiology of the auditory system, audiometry and other assessments, disorders of the auditory system, and practical experience with audiometry and hearing screening.
