Justification for course proposal:

This course is currently listed as a classification of .50 WTU per student for our faculty load. Due to the high demands of this course, and the amount of hours necessary to individually supervise each student outside of the expected teaching and supervision hours, it is necessary that the faculty unit load capture the level of demand on the faculty member's time. Therefore, we are proposing to raise the unit load to .667 WTU per student. We are accommodating this increased load distribution in this course by adjusting down the unit load for several of our field experience courses (EPSY 439 and 441), thereby negating the unit load (fiscal) impact in our program.

Previously, all course codes were changed from EDS to EPSY. Therefore we updated the course description, course note, pre-req and co-req to indicate EPSY.
