Justification for course proposal:

We are making a change to the WTU's for faculty, reducing from .33 to .25. We are making this change as the amount of work per student per faculty member is better captured at .25 for this course. We are also making changes to our WTU's for 243a, b, and c, increasing those WTU's from .50 to .667. We are doing this also to better capture the workload for faculty per student. By these adjustments, we are thereby not making any changes to faculty overall unit allocation for our program (there will be no fiscal impact).

We are also correcting an error in the previous form, which indicated under the Course Components and Classification section that this was a 10 unit course, while instead it varies from 1-10 units depending on the certifications the student is pursuing, and the amount of time they are in the field placement.
