Summary of Changes:

- 1) Course Description: There are changes to the course description that reflect updated course content.
- 2) Removed previous prerequisite: The previous prerequisite designated the course for graduate students in the Multicultural Education MA Program only. With the course serving as a core course for students in the new Ethnic Studies MA Program, we are changing the prerequisite to Admittance to the Ethnic Studies graduate program or instructor permission.
- 3: Department approval for enrollment: Students will need to obtain consent from both the Department Chair and the Professor to enroll in the course.
- 4) Seminar Classification: CS#5 is appropriate for these graduate courses that are seminar and enrollment is limited.
- 5) New ELOS: The ELOS reflect revisions to the course title, description, and content.

6) Change in requirement for teaching credential program from yes to no: This was error when the course was initially created. There is no Ethnic Studies credential program.

This is a core course for the new Ethnic Studies Masters Program. As part of the curriculum, this course fulfills an important need for the Ethnic Studies MA Program and the Department of Ethnic Studies. The course focuses on contemporary issues in Ethnic Studies and helps students differentiate Ethnic Studies as a discipline and decolonizing movement, which often gets lost in the debates about what Ethnic Studies is and its role in mainstream education. Often times, the miseducation and lack of understanding of the origins and purpose of Ethnic Studies lead to mainstream framing of Ethnic Studies as a "diversity" requirement or a course that solely delivers multicultural education for students. This course pays respect to the discipline of Ethnic Studies and its ongoing efforts as a decolonizing movement to bring social change within and beyond education.

In this course, students obtain critical thinking and analysis of contemporary issues in Ethnic Studies, focusing on the current debates and fight for Ethnic Studies in K-12 and higher education which has been always been led by indigenous communities and communities of color (PLO#2; ILOs #1 and 3). Students also examine the fight for Ethnic Studies in mainstream education that operates within the context of settler colonialism, neoliberal multiculturalism, and whiteness, to develop a critical analysis and framing for the ongoing challenges of Ethnic Studies (PLO#2; ILOs #1 and 3).

Students also differentiate Ethnic Studies as decolonizing knowledge to challenge the ways Ethnic Studies gets watered down, misinterpreted, and the controversies that lead to attacks by the mainstream (PLO#5; ILOs #1 and 6). Students also learn that the future of Ethnic Studies connects with its origins and foundations of student/community activism and vision for social change (PLO#5; ILOs #1 and 6).
