Justification for course proposal:

Summary of Changes:

1) Update to course title

The update to the course title reflects revisions of the course description and content that reflects newer trends of the field. Also, the course is being revised to bridge theory and practice, a foundational value of the discipline.

2) Course Description: There are changes to the course description that reflect updated course content. The course description reflects the current and newer trends of the discipline, and advances the previous course with theory and praxis.

- 3) Removed previous prerequisite: The previous prerequisite designated the course for graduate students in the Multicultural Education MA Program only. With the course serving as a core course for students in the new Ethnic Studies MA Program, we are changing the prerequisite to Admittance to the Ethnic Studies graduate program or instructor permission.
- 4) Department approval for enrollment: Students will need to obtain consent from both the Department Chair and the Professor to enroll in the course.
- 5) Seminar Classification: CS#5 is appropriate for these graduate courses that are seminar and enrollment is limited.
- 6) New ELOS: The ELOS reflect revisions to the course title, description, and content.
- 7) Change in requirement for teaching credential program from yes to no: This was an error when the course was initially created. There is no Ethnic Studies credential program.

This is a core course for the new Ethnic Studies Masters Program. As part of the curriculum, this course fulfills an important need for the Ethnic Studies MA Program and the Department of Ethnic Studies. The course delivers the foundations of Ethnic Studies theory and praxis. Since its inception in 1969, Ethnic Studies constitutes the four fields of Africana/Black Studies, Asian American Studies, Chicano/a/x and Latino/o/x Studies, and Native American Studies. As a discipline of these original four subfields, Ethnic Studies has advanced theoretical frameworks addressing the lived experiences of indigenous communities and communities of color within and beyond the U.S. that address issues such as institutional racism, imperialism, white supremacy, decolonization, racial capitalism, and intersectionality. As a course of foundational theories in Ethnic Studies, students analyze theoretical frameworks of the discipline (PLO#2; ILOs #1 and 3).

As one of the first courses students take in the MA program, the course foregrounds the activist origins and purpose of Ethnic Studies (PLO#5; ILOs #1 and 6). Ethnic Studies praxis that bridge academia with indigenous communities and communities of color is essential and foundational to the discipline. Students assess various ways Ethnic Studies is used to create change within and beyond academia, such as decolonizing mainstream education, community organizing/activism, policy and institutional changes, and community engagement (PLO#5; ILOs #1 and 6). Students also create a plan of action that bridges the larger community with ongoing efforts to advance Ethnic Studies in education (PLO#5; ILOs #1 and 6).
