Justification for course proposal:

This is a curricular need as it is a core course for the new Ethnic Studies Master's Program. As part of the core curriculum, this course fulfills an important need for the Ethnic Studies MA Program and the Department of Ethnic Studies. Through course readings and discussions of faculty research, this class provides students with a foundation of Ethnic Studies methodologies in research. As an interdisciplinary field, Ethnic Studies transforms traditional understanding of knowledge, while it simultaneously challenges Eurocentrism and the Westernized University. Throughout the course, students engage and critique the ways knowledge is produced, maintained, and disseminated by traditional disciplines.

The course examines three methodologies specifically: archival research, ethnography, and cultural studies analysis. We examine these methodologies on multiple levels including in the academy, in public media and popular culture, and in marginalized communities. Because of our field's commitment to social change, we will pay special attention to how race, class, gender, sexuality, and other forms of power shape the construction and pursuit of knowledge. This course also allows students to engage with Ethnic Studies Department faculty and to discuss the origins and development of various faculty research projects.

Throughout the course students complete a series of bi-weekly journal entries which evaluate these three methodologies from the humanities and social sciences. (PLO#3; ILOs #1 and 4). Over the course of the semester, each student in the course will facilitate at least one seminar discussion focused on the assigned readings for that week. In facilitating discussions with their peers, students seminar leaders will analyze the ethical standards for community research employed in the week's readings (PLO #4; ILOs #1 and 5). Finally at the end of the term, each student will write a an analytical paper, synthesizing understandings of critical Ethnic Studies methodologies. (PLO#3; ILOs #1 and 4)
