This is a curricular need as it is a core course for the new Ethnic Studies Masters Program. As part of the core curriculum, this course fulfills an important need for the Ethnic Studies MA Program and the Department of Ethnic Studies. In this course, students apply specific Ethnic Studies research methods to develop a prospectus for their thesis or community project. By developing and articulating their distinct research questions, methodological approaches, literature review and timeline, this course allows students a solid basis to complete their thesis or community project in normative time. In developing the prospectus, students engage with relevant and foundational theories, concepts and methodologies in order to develop their distinctive and critical perspective that will undergird their thesis or community project. Students will create research questions, choose the appropriate methodologies to study those questions, read relevant academic literature related to their research, write a prospectus, and receive feedback on that prospectus from their peers and the instructor. Students will also employ ethical standards of the discipline in their thesis or community project (PLO #4; ILOs #1 and #5).
