#### Justification for course proposal:

This is a curricular need as it is an elective course for the new Ethnic Studies Masters Program. As part of the curriculum, this course fulfills an important need for the Ethnic Studies MA Program and the Department of Ethnic Studies.

People of African descent in the last two centuries have found themselves at the leading edge of the development of social justice, equity, the Human Rights Movement. During these two centuries African descended populations both in Africa and the African Diaspora have developed unique cultural, political and economic patterns including an attempt to unify African descended peoples in various countries, regions and globally across traditional political boundaries. This is an ongoing process which needs to be studied through an interdisciplinary lens (politically, culturally, psychologically, economically, etc.) to really ascertain the achievements and depth of this development. Many of the fundamental elements of Ethnic Studies such as mass movements and interdisciplinary theory first developed within Pan African Studies as such this course is essential to the study of Ethnic studies.
