### Briefly describe the program proposal (new or change) and provide a justification:

The Program Learning Objectives have been updated so that they better align with Bloom's taxonomy.

Addition of a new course, ENVS 170 to Major electives Removal of a no longer taught course, ENVS 124 (A 'Form A' for this purpose has also been submitted concurrently). The addition of ENVS 170 to replace ENVS 124 is to update the curriculum from a general social justice content to an environmental justice emphasis so that the course is better aligned our Department's other course offerings and learning objectives.

Correction of structure so that an optional course, ENVS 199, is no longer counted towards total units. ENVS 199 was never required for the ENVS Major. It has always been an optional course. However, due to a quirk in the structure of the catalogue it has been included in the calculation of total units (creating an unnecessary administrative requirement to waive units for many ENVS majors). We are moving ENVS 199 into the elective category to reflect its actual status as optional.

Because dealing with environmental issues requires an interdisciplinary approach, we emphasize the development of strong writing, research, and quantitative skills and a broad liberal arts perspective.
