### Briefly describe the program proposal (new or change) and provide a justification:

This program change proposal is a comprehensive revision of the BFA in Interior Architecture. The revision is a result of further goals to make the lower-division courses transfer-friendly, to update changes to the Department of Design core courses, and to remove the highly sequenced co-requisite upper-division curriculum. Changes include:

- Changes in the Program Description and Learning Outcomes to further clarify the goals and outcomes of the degree and provide information about professional certification.
- Adding two lower-division architectural history courses that replace INTD 123 and INTD 20.
- Moving two of the four graphic communication courses to the lower division.
- Changes in the lower-division interior architecture courses that embrace a shared lower-division curriculum for Interior Architecture and the new Architecture Studies degree.
- Changes in the course name, number, description, and outcomes of all courses to add structure to understanding the curriculum.
- Adding three major electives to allow for student individualized pathways, future certifications, and transfer credit for relevant coursework.
- Reduction in overall unit requirements.

Additionally, the Department of Design is changing the common core of classes that all majors in the Department of Design must take. The objectives of these changes are to:

- Alleviate scheduling and facilities constraints that slow student progress to graduation
- Increase flexibility for students in scheduling their classes.

- Facilitate transfers
- Refine existing course needs to achieve program learning outcomes.

We do not anticipate these changes affecting students in majors outside of the Design Department.

Please note that the above program changes are the first phase of a multi-phase curricular change. The complete change will take place over a three-year period to help alleviate the enormous workload of curricular revision with limited faculty and no release time. The final version of the curriculum is attached as an additional support file for reference purposes only.

# **Program Description**

The Bachelor of Fine Arts in **Interior Architecture** is intended for students pursuing professional careers as interior designers/interior architects. The Program provides students with the knowledge and skills to shape interior-designed environments responsibly. Combined with the CSU General Education requirements, the breadth of courses in the program reflects the values of professional preparation grounded in a liberal arts education. The Program is one of five-degree programs offered in the Department of Design (https://www.csus.edu/college/arts-letters/design/) and shares a lower-division curriculum with the Bachelor of Fine Arts in Architecture Studies.

The Interior Architecture program encompasses a broader understanding of designing interior environments. Students learn both "interior" and "architectural" ways of thinking and designing as they develop the knowledge, skills, concepts, and sensitivities essential to professional life. Students are educated in architectural history/theory, interior architecture studio practice, interior construction practices, building mechanical and electrical systems, FFE research and specifications, graphic communication, and professional practice. The Program fosters an interdisciplinary approach to designing interior environments with particular attention to the design's impact on environmental, social, and cultural systems.

A central part of interior and architecture education is the design studio, where students thoroughly examine design problems using experiential and project-based learning to prepare for the competitive rigors of the changing world they will face after graduation. Studio culture is non-competitive and supportive, emphasizing collaborative models of learning. Guest lecturers, professional panel critiques, discussions, field trips, and building tours of outstanding projects maintain strong connections to the profession. Service-learning opportunities form an important component of the curriculum.

The upper-division curriculum provides students with the design and technical skills needed to practice interior design/interior architecture and sit for the NCIDQ and/or IDEX examinations. The Council for Interior Design Qualification (NCIDQ) (https://www.cidq.org/) oversees the NCIDQ Examination, which is required for interior design licensure/registration in every regulated US jurisdiction except California. The California Council for Interior Design Certification (CCIDC) (https://ccidc.org/) oversees Interior Design Certification in California through the IDEX® California Exam.

Sacramento State is accredited by the National Association of Schools of Art and Design (NASAD), designated by the U.S. Department of Education as the agency responsible for the accreditation of art and design programs in the U.S.

The Curriculum Committee has approved this proposal pending the following edits: Further development of the Program Justification regarding the 1 unit increase (not adding courses, only 1 unit which is consistent across all design courses), and a re-working of the PLO's which are currently redundant. Please diversify and clarify so the PLO's to do not all begin with "demonstrate". Thank you!

Rachel Miller (rachel.miller) (Wed, 20 Sep 2023 18:28:43 GMT): Rollback: Due to federal financial aid regulations, it is not advisable to have students repeat a 4-unit course as a part of a degree for a total of 8 units. To avoid a federal financial aid audit, we are asking that programs instead differentiate courses and have students take, for example, INTD 110A and 110B, with differentiated learning outcomes (using higher level Bloom's taxonomy verbs for INTD 110B to show that students are building on the skills they were first introduced to in INTD 110A. In addition, the committee is asking for one minor revision: Your second PLO uses the verb "Demonstrate an understanding." We are asking programs to revise PLOs that use language such as "Students will know/understand..." or "Students will demonstrate an understanding of..." Instead, we ask that you select a verb that highlight what students will be able to do that will demonstrate their understanding.
