## Justification for course proposal:

This course is offered as part of a teaching credential program at Sacramento State for a single subject teaching credential in Family and Consumer Sciences/Home Economics.

In 2019, the Nutrition and Food program was elevated to stand alone degree and changed their course code prefixes. This change in prefixes was handled through a spreadsheet provided to the Register rather than submitting ~60 individual Forms A. At that time, staff assumed that content of all post-baccalaureate courses in the department were for Nutrition and Food. We request that the course subject code be changed back to FACS to better align with the content and title of the course. The prefix of NUFD is for Nutrition and Food courses, for which this course is not aligned. This change will make it easier for prospective students to identify the course they need to complete requirements for a single subject teaching credential. This it will also help credentialed teachers find this course when they seek to to add a Family and Consumer Sciences (FCS)/Home Economics Careers and Technology (HECT) teaching credential.

The catalog description has been updated to clarify the expectation that students will be engaged in practicing teaching skills/ pedagogy.

We are also updating the term in which this course is offered. There is insufficient demand in summer, but we have identified demand in fall for the past several academic years.

We are requesting to update the classification to better align with the workload and course delivery. The course includes practice teaching during class meetings and students develop their lesson plans through independent study with instructor supervision. We have updated the syllabus to reflect the expectation of independent development and practice of/for delivering teaching demonstrations.

The prerequisite has been updated to better inform credentialed teachers seeking to add FCS/HECT teaching credential that this is the course required by the California Commission on Teacher Credentialing. We have added the language about instructor permission needing department approval because the classification code changes the teaching assignment based on enrollment (0.5 Weighted Teaching Unit per student enrolled). This allows the department and college to efficiently manage their contract obligations.
