#### Justification for course proposal:

There has been a long-standing inequity in applied study requirements between students enrolled in the Bachelor of Music Jazz Studies performance degree and students enrolled in the Bachelor of Music classical performance degree. Currently, lower division BM Jazz Studies students receive only 1 unit of applied study per semester for a total of 4 units, whereas lower division BM classical performance students receive 2 units per semester for a total of 8 units. In order to give all students in these degree plans an equitable experience, lower division students in the BM Jazz Studies program should receive the same amount of units for applied study as the students in the BM classical performance concentrations: 8 units total. Our proposal is intended to address this inequity.

We propose to delete MUSC 50, Jazz Applied: Intermediate (1 unit) and replace it with MUSC 50A Jazz Applied Study: Intermediate (1 unit) for students in the Bachelor of Music, Jazz Studies/Music Education or the Bachelor of Arts in Music degree plans, and to add MUSC 50B Jazz Applied Study: Intermediate-BM (1 unit) for students enrolled in the Bachelor of Music Jazz Studies performance degree: they will enroll in both MUSC 50A and 50B, in order to receive 2 units of applied study instruction each semester of their lower division enrollment. This addition will increase the required unit count by 4 units.

To offset this increase, we will propose to delete MUSC 118B from the upper division requirements. Students will be advised to take this course to satisfy GE Area C. The overall unit count for their degree plan will therefore only be increased by 1 unit, which we feel is justified.

We will submit a Form B to show these changes for both degree plans (BM Jazz Studies, and BM Jazz Studies/Music Education) that includes an explanation of the budgetary impact this change will have on the School of Music.

Our accrediting body, the National Association of Schools of Music (NASM), recommends that students enrolled in applied study practice at least 3 hours weekly for every 1 unit of credit they receive each semester. By increasing the number of units applied study for BM Jazz Studies students at the lower division level, we would be in compliance with NASM recommendations.
