Briefly describe the program proposal (new or change) and provide a justification:

This proposal reduces the unit requirement from 21 to 15 units, adds HRS 198 as a required course, and removes the areas of study in favor of a broad list of electives.

The minor would consist of 9 units of required courses—HRS 4, HRS 108, and HRS 198—and 6 units of electives selected from any upper-division religious studies courses.

Rationale

Unit Reduction

By reducing the unit requirement from 21 to 15, students will more likely be able to pair the minor with their major program. Having a high number of units will dissuade otherwise interested students from pursuing the minor, as they will struggle to fit the program into their schedule.

HRS 198

HRS 198 is a requirement for Religious Studies majors, but is typically under enrolled. By including HRS 198 as a requirement for minors, we will increase numbers in the classroom which will enhance the learning experience for all the students. Further, requiring the full suite of courses, namely HRS 4, 108, and 198, students will be given a holistic sense of the field.

Areas of Study

By removing the areas of study, students will be provided with more freedom to select their remaining courses and ease their path to the degree. With the reduction in units and the addition of HRS 198, two electives are left. If the areas of study remained, students would be greatly restricted, and several religious studies courses categorized as 'supporting courses' would be inaccessible. Instead, students would be able to complete their remaining units with any upper-division religious studies courses, thereby enhancing their ability to pursue their academic interests.

Program Description

The Department of Humanities and Religious Studies offers an integrated approach to the study of world cultures from ancient times to the present. In our courses, students undertake interdisciplinary study of core ideas, ideals, and values. The Humanities – known by Renaissance thinkers as *studia humanitatis* ("studies of humanity") – explore such subjects as literature, history, philosophy, religion, the visual arts, music, drama, and film. Religious Studies focuses on beliefs and practices of the world's religions in their historical and cultural contexts. Employing the methods and insights of disciplines such as history, anthropology, sociology, psychology, and philosophy, Religious Studies approaches its subject matter with empathy while avoiding assumptions or judgments about religious truth claims.

Students in all five available programs acquire concrete skills in critical thinking, analysis, research, writing, and organization that lead to attractive careers throughout the job market. Many of our students prepare for careers in teaching at the elementary level (as part of a Liberal Studies major program) or secondary level (as part of a single subject credential program in English/ Humanities). Others pursue postgraduate study in the Humanities, History, Theology, and related fields in preparation for careers in teaching at the community college and university levels or in library, museum, or curatorial work. Humanities majors are also well-prepared for careers in government and fields such as law and counseling, which require interaction with people from diverse cultural backgrounds.
