### Justification for course proposal:

The Art History program is revising all of our upper-division art history courses in order to better align course ELOs with the program's learning outcomes, make our prerequisites more flexible and accurate, and balance the number of GE courses in the various areas of the program.

For ART 103, specifically, the following changes are requested:

- Accurately displaying how often the course is offered: This course is only offered during the fall term of odd years, not every fall.
- Adding this course to GE: Historically, Art History program courses were rather haphazardly added to GE, based on a perception of which ones needed help filling. This has led to curricular imbalance. None of the art history Group 1 courses (European art) are in GE, while almost all of the Group 2 (Asian art) and Group 3 (Art of the Americas) courses are. This means that students who focus on European art receive more in-depth instruction and complete assignments that require increased expertise and skill, while students who study Asian or American art, including Latin American art, take most of their major courses as less advanced GE courses. As a result, we have had very few students who want to focus on Asian or American art go on to graduate study. The vast majority of art history students who have gone to graduate school in recent years have focused on European art. Adding one of our Group 1 (European Art) courses to GE, while removing several of the Group 2 and Group 3 courses will allow us to address this imbalance.
- Changing the pre-requisite: Since we are adding this course to GE, we are requesting a change to the pre-requisite in alignment with our other upper-division GE courses. Also, the Art History program has recently redesigned our entire lower-division art history curriculum, but the upper-division course pre-requisites were never altered to fit the new curriculum.
- Changing course description: We'd like to provide more information in all of our upper-division courses to give students a more detailed idea of what the course will cover. The curriculum itself is not changing; the new course description is just more reflective of what is being taught.
- Edited ELOs When Art History was elevated to its own BA, we wrote new Program Learning Outcomes. We revised our lower-division course ELOs to be in alignment with these new PLOs, so we are now aligning upper-division courses as well. Again, the curriculum is not changing, but we are doing a better job of writing ELOs that accurately reflect the curriculum.

Topics include religious architecture and cult statues, domestic art, the depiction of the human form, and art that was intended to display political power.
