Justification for course proposal:

The Art History program is revising all of our upper-division art history courses in order to better align course ELOs with the program's learning outcomes, make our prerequisites more flexible and accurate, and balance the number of GE courses in the various areas of the program.

For ART 106, specifically, the following changes are requested:

- Changing the pre-requisite: A few years ago, the Art History program redesigned our entire lower-division art history curriculum, but the upper-division course pre-requisites were never altered to fit the new curriculum. The proposed changes to the pre-requisites for ART 106 better align the LD and UD curriculum and provide more pre-requisite options to students.

- Changing course description: We'd like to provide more information in all of our upper-division courses to give students a more detailed idea of what the course will cover. The curriculum itself is not changing; the new course description is just more reflective of what is being taught. In 2016, the Art Department hired a faculty member whose expertise is art and intercultural exchange, specifically in placing European art within a broader global context. This faculty member has been teaching all of their courses with this emphasis, but these courses were never formally updated.

- Edited ELOs - When Art History was elevated to its own BA, we wrote new Program Learning Outcomes. We revised our lowerdivision course ELOs to be in alignment with these new PLOs, so we are now aligning upper-division courses as well. Again, the curriculum is not changing, but we are doing a better job of writing ELOs that accurately reflect the curriculum.

While covering Italian Renaissance artists such as Botticelli, Leonardo da Vinci, Raphael, and Michelangelo, this course also presents an expanded view of the Renaissance focusing on other artistic centers such as Lisbon, Nuremburg, Madrid, Mexico City, Goa, Antwerp, and more. Emphasis will be placed on Renaissance painting, sculpture, architecture, and prints within the context of global trade, Catholic missionary activities, and European colonization.
