Justification for course proposal:

We would like to increase the number of times a student may take the course for credit from 1 to 2. There are two purposes in making this adjustment to the course:

• To further increase the number and flexibility of upper division options available for students.

• To allow students to build substantively on the experience gained during their first experience in the course. When we proposed the course in 2023, we did not anticipate that students would want to repeat the course due to the conceptual emphasis of this studio course. We offered the course in Spring 24 and for the second time in Fall 24. Two students requested to repeat the course in the Fall in order to further develop the experimental methodologies supporting their artistic practice. The experience the repeating students brought to the course was quite beneficial to the class as a whole. They were able to encourage and mentor their colleagues as they navigated the difficulties of the course content. More importantly, the repeating students made valuable progress in the development of their own expressive purposes. We expect to offer the course every semester and are offering the course again this spring semester (2025). Three students have requested to repeat the course this spring. While we can accommodate these students somewhat awkwardly via course substitutions, we anticipate that financial aid will challenge the repetition of the courses. We believe that the pedagogical benefits and the practical benefits will be significant if we can allow students to repeat the course.

Students will put into practice a range of experimental methods to the purpose of discovering new approaches to their medium, and new avenues for the articulation of content. Scott Perkins (scott.perkins) (Fri, 07 Mar 2025 18:55:58 GMT): The course description has a typo and seems a little clunky to me. Suggestion, which is still a bit of a run-on: "This course will focus on investigating and putting into practice experimental methods to discover new approaches to their medium and new avenues for articulating content. Work will focus on a medium and subject matter of the student's choice." ELO 4 reads strangely to me as well with "serve" and "in the service." The assessments listed in the syllabus are different from those in the Form A. I recommend listing all of the Form A assessments in the syllabus, showing the ELOs to which they correspond, and specifying the weight of each one. There is also no "description of the minimum requirements necessary to earn each letter grade," per the syllabus policy. The name of Student Health, Counseling, & Wellness Services needs to be updated in the syllabus.
