### Briefly describe the program proposal (new or change) and provide a justification:

This proposal increases the number of elective courses—from one to five—to add more flexibility to the Spanish B.A. curriculum. While maintaining the traditional curriculum for language degrees (literary analysis, extensive language study, and cultural understanding), the proposal adds coursework in Spanish for the professions (translation, criminal justice, and healthcare) to enhance students' employment possibilities by making them more adaptable to different job markets and career paths.

These changes in the Spanish BA will help students to develop strong Spanish language skills and cultural awareness to succeed in different professional settings.

This proposal updates the course requirements as follows:

- 1) Increases the number of elective courses
- 2) Includes coursework in Spanish for the professions (translation, criminal justice, and healthcare) to enhance students' employment possibilities by making them more adaptable to different job markets and career paths.
- 3) The proposal does not change the number of units required for the SPAN major.

## **Program Description**

A working knowledge of Spanish will enable students to communicate with one of America's rapidly growing minority groups, as well as to benefit extensively from travel to foreign countries. Most coursework lends itself to a practical acquisition of the necessary linguistic and cultural competency for effective communication in the workplace and Hispanic/Latino communities.

Coursework at the upper division and graduate level is equally distributed among four areas: linguistics, culture, Peninsular literature, and Latin American literature. The coursework will also enhance the employment possibilities of students with career goals in other fields (translation, teaching, healthcare, social work, criminal justice) that require knowledge of specialized terminology in Spanish. Students with career plans in business administration, public administration, and international relations will find a balanced

curriculum available at Sacramento State. The Spanish BA also serves those students who plan on continuing their studies at the doctorate level by providing a thorough academic background in the language.

Students interested in Bilingual/Crosscultural programs should also contact the College of Education (916) 278-6840 for more details.

## **Minimum Grade Requirement**

All Spanish majors must earn a grade of "C" or better in all courses counted toward the major. SPAN 142 may be taken by challenge exam for Credit/No Credit only provided that student enrolls in course.

## **Required Lower Division Courses**

It is assumed that Spanish majors will have completed the equivalent of college level elementary and intermediate Spanish in high school, at a community college, or by completing SPAN 2B<sup>1</sup> at Sacramento State, prior to beginning upper-division courses.

Course also satisfies General Education (GE)/Graduation Requirement.

## **Study Abroad Programs**

Students having a 2.75 GPA average overall are eligible to apply for admission to the CSU International Programs in a Spanish-speaking country such as Chile, Mexico, or Spain for their junior or senior years or during graduate studies. Spanish skills must be sufficiently developed to permit satisfactory performance in a Spanish-language university; planning from the beginning of the freshman year is advisable. Programs are also available for beginning students in Spain and Mexico. For details, contact International Programs and Global Engagement and consult a member of the Spanish faculty about developing your language skills.
