Briefly describe the program proposal (new or change) and provide a justification:

NOTE: To be eligible to pursue the Certificate in Pan African Studies, students must be enrolled in the Cooper-Woodson College Enhancement Program (CWC). CWC scholars must earn either a certificate, minor or major concentration in Pan African Studies as a curricular requirement of the program.

The reason we are proposing the following changes to the Certificate in Pan African Studies is because the current certificate is 24 units and exceeds the number of units for all minor programs in Ethnic Studies, which is 21 units for each. In other words, the courses needed to complete this certificate exceed the number of courses needed to complete a Pan African Studies minor.

We are also reducing the number of units in this certificate to be more in line with typical certificates in academic units across campus. Lastly, with this certificate being the minimum curricular requirement for CWC Scholars who come from a variety of departments and majors at Sac State, some of which are high unit majors, we wanted to change our high unit certificate to a lower unit certificate to support students' ability to meet the requirements of CWC.

As CWC is a Black student retention co-curricular program based in the Pan African Studies Program in the Department of Ethnic Studies, this proposal seeks to create an avenue for all CWC scholars, regardless of major, to complete an academic credential program in Pan African Studies upon graduation.

The Cooper-Woodson College Enhancement Program (CWC) was founded in 1990 as an Educational Equity, Pan African Student Retention Program, through the leadership of Dr. Otis Scott, Chris Glen, and David Covin. The name is a tribute to the legendary legacies of Anna Julia Cooper and Carter G. Woodson! The founders formulated the theoretical framework of the program based on the principles of *Leadership, Scholarship, and Service!* This tagline continues to define the mission of the program, and its influence can be felt around the world.

It is an association of faculty, staff, students, and community members who are committed to recognizing and upholding the tradition represented in Pan African cultures that are best expressed in relationships between historically Black Colleges and students. It involves adults in the community assuming responsibility for shaping and guiding a learning environment supportive of, responsive to, and nurturing of CWC students.
