Non-substantive Program Changes for the BS in Family Studies and Human Development major

The faculty in Family Studies and Human Development (FSHD) propose a revised curriculum that will not change the number of units required (51).

Justification: These three revisions are necessary in order to a) incorporate a proposed new course, FSHD 51, Intimate Relationships, a course that meets the needs of all of our majors, and particularly those who have a career goal that includes working with couples and families; and b) provide additional options to our students in order to expedite their progress toward a timely graduation.

Proposed Changes are as follows:

- 1) A new course, FSHD 51, Intimate Relationships, upon approval will replace the current requirement of either Soc 8 or Stat 1. This moves 3 units that are currently outside the major to 3 units inside the major.
- 2) Where we currently require all majors to take FACS 168, Senior Seminar, we propose to now have three options: FACS 168, Senior Seminar, OR FACS 195C, Internship, OR FSHD 195F, Practicum in Family Life Education. This change is in response to student need and also in response to the President's Strategic Priorities which include increasing the number of students who complete an internship prior to graduation. Currently, students who select to complete an internship or practicum do so IN ADDITION to all major requirements. This change will allow the internship or practicum to count in place of a required course in the major.
- 3) We require 3 units of electives from an approved list (or with advisor approval). Without increasing the number of units required in electives, we propose adjusting the list to remove two of the current options (FASH 137 and NUFD 114) as they have been determined to be less relevant to our overall program objectives, and adding several more relevant options to the approved list of elective courses.
