Briefly describe the program proposal (new or change) and provide a justification:

We are proposing changes to the B.S. in Gerontology for the following reasons:

- 1. We only have one lower division major requirement. We propose requiring a second lower division Gerontology course to provide majors with a stronger foundation as they move into upper division major courses.
- 2. The Department recently shifted from a mostly in-person program to a hybrid degree. This enables us to recruit students who would otherwise not be able to complete their Gerontology degrees at Sac State, including students who are working and/or caregiving full-time. However, while we have converted most GERO courses to an online format, we are not able to control the modality and frequency of courses offered by other departments. This has caused problems for Gerontology majors when a non-GERO course that is required for the major is not offered on-line or not offered in the semester they need to graduate on time.

 3. While some Gerontology majors are needing to complete the degree mostly online other students are seeking a mix of in-person
- 3. While some Gerontology majors are needing to complete the degree mostly online, other students are seeking a mix of in-person and online course options either due to their preferred learning styles or because their student aid requires at least some in-person courses (e.g., military-based financial aid).
- 4. We have received feedback from internship placement agencies and members of the Gerontology Advisory Council on our current course offerings. These local employers and community partners have encouraged us to include more course content relevant to what Gerontology graduates are likely to do in the field (e.g., nonprofit management, health care administration, senior activities programs, navigating ethical issues).
- 5. Currently, we require Gerontology majors to complete a two-semester practicum (GERO 130 and GERO 131). Many students who are working and/or caregiving struggle to complete the required 8-10 hours/week at agencies over the course of two semesters. Due to faculty and staff reductions, the department has more limited capacity to manage and support all majors to complete two-semester internships. We have consulted with members of our Advisory Council and agencies that frequently work with Gerontology interns. Based on this feedback, we have concluded that, while the two-semester internship provides a deeper learning experience, making the second semester optional preserves the essential benefits students gain through the practicum while lifting some of the burden from students and the department.

Based on the above justifications, we are proposing the following changes (numbers indicate which justifications are addressed by each proposed change):

- Make GERO 10 a required course (currently an elective) (1)
- Make ETHN 133, FACS 141, SWRK 151, and RPTA 117 electives rather than required courses (2)
- Add FACS 100 to the list of courses that can fulfill the research course requirement to give an in-person option (3)
- Expand the number of electives majors take from three to six (3, 4)
- Expand the elective course options to include approximately 40 courses related to ethics, health and healthcare, physical activity and leisure, leadership, family and social wellbeing, mental health, financial wellbeing, human development, and special populations and topics (3, 4)
- Make GERO 130 (currently the first semester of the required practicum) an elective rather than a required course (5) As we make these changes, we are also updating course listings that have changed and deleting one PLO that we determined to be redundant.

The roadmap changes include adding more major electives and removing ETHN 133, FACS 141, and RPTA 117 from the required courses. We shifted GERO 10 and GERO 11 to Year 2 to reflect the recent change from upper division to lower division. We also updated the roadmap to illustrate what GE requirements will be fulfilled with major required courses and which GE requirements may be fulfilled with a major elective.
