Briefly describe the program proposal (new or change) and provide a justification:

This proposal is part of a suite of updates—largely administrative—to the BS in Hospitality and Tourism Management (HTM).

The proposed changes are required to ensure that the 26-27 catalog accurately reflects the reorganization of the College of Health and Human Services approved in Spring 2025, in which the HTM program moved from the RPTA Department to the Department of Public Health, and other RPTA programs moved into the Departments of Kinesiology (BS in Recreation Administration) and Allied Health Sciences (BS in Therapeutic Recreation). Modifications to these degree programs are also being proposed for the 26-27 catalog.

All courses in the current HTM degree program that will continue to be taught have a new prefix (HTM); they will no longer have the RPTA prefix.

References to the RPTA Department, RPTA courses, and RPTA majors were removed. Other modifications, including a number of course proposals that follow this program proposal, were made to 1) more effectively situate HTM within its new department and 2) differentiate the degree from other majors that shared courses with HTM, and are now located in other departments.

Note: This academic year, the faculty in the Department of Public Health are undertaking a revision of our offerings to carefully and thoughtfully integrate programs. More substantive changes will be proposed in AY 26-27 for catalog 27-28.

Program Description

Hospitality and tourism are two of California's fastest growing and most important industries. The **BS** in **Hospitality and Tourism**Management allows students flexibility in the selection of courses related to hospitality and tourism management, administration of service organizations, and event planning. Curriculum focuses on hotel management, tourism destination marketing, and convention and meeting planning, as well as the basics of entrepreneurial businesses, and the skills needed for working with for-profit, and experience industry agencies (e.g., resorts, ski lodges, conference and meeting facilities, cruise lines, theme parks, destination marketing agencies, spas, clubs, and travel agencies). Local industry professionals from the Sacramento Hotel Association and Visit Sacramento (Sacramento Convention and Visitors Bureau) work closely with department faculty to give students practical skills associated with internships and jobs in the industry.

Note:

• Students graduating with a Bachelor of Science Degree in Hospitality and Tourism Management are not be subject to the University's Foreign Language Graduation Requirement. Students who change major may be subject to the University's Foreign Language Graduation Requirement.
