### Briefly describe the program proposal (new or change) and provide a justification:

We are changing the Gerontology minor to provide more flexibility to students. We are also making the one-semester practicum optional rather than required. Unfortunately, the Department does not have the capacity to support all minors in internships. We have also observed that the practicum requirement can lead interested students to not pursue the minor, so we hope this change will encourage more students to minor in Gerontology. As we make these changes, we are updating course listings that have changed (GERO 100 is now GERO 10, GERO 101 is now GERO 11, FACS 159 is now FSHD 159).

The proposed changes would reduce the total units from 21 to 18. Gerontology is not a well-known field of study. Students frequently discover Gerontology by taking a GERO course to fulfill a GE requirement or as an elective in their major. With a 21 unit minor, it will take a student who has taken just one Gerontology course two more semesters to complete the minor (18 units left if they happened to take a course that fulfills the minor, otherwise 21). By reducing the total units to 18 and expanding the list of Gerontology courses that count towards the minor, a student who starts the minor after taking any Gerontology course could complete the minor in one semester (15 units left). We anticipate this will make the Gerontology minor more accessible and increase the number of Gerontology minors.

The proposed changes would allow minors to select five or six courses from among 10 courses offered by the Gerontology Department. Minors will be able to choose to satisfy three units of the minor with one of the following aging-related courses offered outside of the Department: KINS 136: Sport & Aging, PUBH 150 Aging and Health, PSYC 150: Psychological Aspects of Aging, FSHD 159: Adulthood & Aging in Human Development, or ETHN 133: Cross Cultural Aging in America.

Below is a summary of what is currently required for the minor and how this proposal would change these requirements:
- currently all of the following courses are required for the minor: GERO 10 (was GERO 100), GERO 11 (was GERO 101), GERO 102, GERO 103, ETHN 133, GERO 131. Under the proposed minor change, these courses would still fulfill the minor but would not be required.

- -currently, minors must take one of the following three courses: GERO 121, GERO 122, or FSHD 159. Under the proposed minor change, these courses could still be used to fulfill the minor but would not be required.
- -Other Gerontology courses currently cannot be used to satisfy the minor. This proposed minor change would allow students to take GERO 123, GERO 124, and/or GERO 125 to satisfy the minor.
- -Non GERO courses (except for ETHN 133 and FSHD 159) currently cannot be used to satisfy the minor. This proposed minor change would allow minors to take one of the following to satisfy three units of the minor. KINS 136, PUBH 150, PSYC 150, FSHD 159, ETHN 133.
