The Department of Theatre and Dance has developed 6 Program Learning Outcomes (PLO) for the BA in Theatre program. Those PLOs include students' ability to:

- 1. Recall and define key disciplinary ideologies.
- 2. Understand and interpret the elements of performance.
- 3. Analyze performance texts/compositions in relationship to specific contexts.
- 4. Demonstrate professional standards as artists throughout the audition, rehearsal, and performance process.
- 5. Evaluate live performance.
- 6. Create performance.

This academic year, the program assessed the 2nd PLO. More specifically, we examined students' ability to understand Aristotle's foundational elements of drama (plot, character, thought, language/ diction, song, and spectacle) that together compose theatrical productions and interpret how these elements operate both individually and collectively in play texts and productions. Aristotle's six elements of tragedy are the foundation of Western theatrical practice. Students must be able to articulate how these elements operate to demonstrate their basic competency, i.e. understanding of core content, in the discipline of theatre.

The department engaged in a formative assessment and administered a test at the end of spring 2014 semester. The test evaluated students' understanding of Aristotle's six elements of tragedy. The test scores for this PLO are as follows:

The test average was 75.8% (C); the highest score was a 100% (A), and the lowest score was a 56.3% (F). This data suggests that students' overall understanding of Aristotle is average upon completing THEA 4.

Students are doing extremely well identifying the six elements of tragedy. 98.7% of those tested correctly listed the elements on the test. Students need to improve their defining and interpreting of the elements. 79.48% successfully defined each term and 68.4% successfully interpreted

each term in an open-ended short answer response. Students struggle to articulate exactly how the elements operate in play texts, and they fail to sufficiently support their ideas with examples.

The Theatre program did not set an explicit standard of performance for the PLO in advance of completing the assessment. This was our first year exploring this PLO using this testing method, and it enabled us to set the benchmark for further assessment. We now expect that students will improve in this area and all score 80% or better on future assessments of this PLO.

The Theatre program administered a 3-question, short answer test the last week of class to the THEA 4. Script Analysis class, which consists of 26 theatre majors. THEA 4 is the course that introduces and focuses on Aristotle's *Poetics*/Six Elements of Tragedy in the curriculum. Students are expected to complete the course with a strong understanding of the elements. Other classes in the curriculum further develop these skills. For instance, THEA 101. Acting II

delves more into character analysis, and THEA 123. Design for Theatre delves more into spectacle design. The data is reliable and valid for an introductory course.

- 1. Adjusting course structure in order to unify language/terminology across classes, so Aristotle's elements are revisited in multiple classes. In other words, the faculty plans to use more repetition to teach this PLO.
- 2. Focusing on interpretation across classes to encourage students to better articulate their own ideas. Students must learn to synthesize information to interpret meaning for all PLOs. The faculty plans to concentrate on assignments and projects that force students to move beyond basic content comprehension to more in-depth analysis.
