# Discussion of FS 19/20-132 MOU Between CFA and OFA Regarding Spring 2020 Student Evaluations

The Senate discussed a proposed memorandum of understanding between the California Faculty Association and the Office of Faculty Advancement regarding student evaluations for Spring 2020. The proposal would allow faculty to remove any items from their student evaluations that were negatively impacted by the COVID-19 pandemic or, alternatively, to permanently insert into their PAF a statement that would contextualize the student evaluations. Senators asked questions about how many and what type of items could be removed, how direct of an impact would the COVID-19 effects need to be for item removal, and who would decide if a removal was appropriate, and when would the removed items be destroyed. CFA Chapter President Berta-Avila and Interim Vice Provost DeGraffenreid were on hand to answer questions.

#### **REFERRAL**

FS 19/20-123/UARTPC/EX University Appointment, Retention, Tenure and Promotion Policy Amendment of Section 5.05 E.1.c.1: Criteria for Retention, Tenure, and Promotion: Procedures to Govern the Administration of Written (paper) Student Evaluations

A motion was made and carried to refer the item back to the University Appointment, Retention, Tenure and Promotion (UARTP) Committee to consider the concerns raised (below) or others that might be raised. The item will return to the Senate upon the UARTP Committee's review.

- 1. <u>Procedures for Broken Chain of Custody</u>: The policy requires a sealed envelope, signed, and dated, to be delivered in a certain manner, and only to be handled by certain people. But the proposal is silent as to what happens to the evaluations if any of those conditions aren't met if an envelope arrives open (never sealed or visibly unsealed), unsigned, undated, etc. How is the "chain of custody" established who contacts whom to verify if the evaluations have been compromised or seem OK to continue with?
- 2. <u>Procedures for Absent Student Responses:</u> Some units allow a student with a verifiable absence from the day that paper evaluations were conducted, to complete an evaluation later in the office but before the package is submitted. Is there a process to accommodate this (perhaps unseal/reseal/re-sign/re-date or new envelope/seal/sign/date maybe include the original envelope?). This could cause the problems from (1) above if simply unsealed and sent forward. *Carried.*
