• Acknowledgement of Dean Chevelle Newsome: The Graduate Studies Policies Committee Chair acknowledge and thanked for all that she has done for the committee over the year.

Approval of the Agenda:. The agenda was amended to add after #10: Sacramento State Faculty Senate Resolution to Establish a Mutual Defense Compact to Protect Academic Freedom, Shared Governance, and Diversity, Equity, and Inclusion in the CSU. The amended agenda was approved. *Carried*.

From the Chair:

- The Executive Committee will meet on Tuesday, May 13, via Zoom. If needed, the Senate will meet on Thursday, May 15 via Zoom.
- May 1, 2025 Senate meeting: At adjournment the Senate had not acted on a motion regarding a moratorium on unit reorganization proposals. If the Senate wishes to take up the item, it would need to be added to the May 8 agenda during approval of the agenda.
- President Wood's proposed amendments to the University Appointment, Retention, Tenure, and Promotion Policy, Section 5.05E Competent Teaching Performance (FS 24/25/UARTP/EX):
 - The Chair felt that faculty are at odds with the proposed language from the Administration: No specific minimum SET score shall be used as a standalone criterion for retention, tenure, or promotion decisions unless an academic unit has established and justified such thresholds in their approved policies.
 - The Provost felt that the administration and faculty are not at odds, that it's clarification of not understanding intent. The President and Provost are willing to work on understanding intent of the revision and supports looking at the item in the fall with the incoming Senate.

From the Provost:

- Administration is following the posts regarding a hunger strike by a group of students and monitoring the situation. The strike is systemwide and there is no set deadline to the strike.
- Graduate Studies and Undergraduate Studies transition: Information regarding the interim appointment for the Dean of Graduate Studies and also the oversight of the Undergraduate Studies transition will be announced soon.
- Human Resources will be announcing on Thursday an early exit program for faculty.

 - Under Pre-Requisite Requirements, the "he/she" should be changed to either "the student" or "they".
 - Please look to clarify the footnotes. On the bottom of page 6, footnotes 1,2 are noted. Their descriptions occur on page 7.
 - One of these descriptions references a 'course,' but the use of the footnote is for the broad heading surrounding GE.
 - Then later, items are marked with a footnote again in a few places. These occur for subject headings, but also specific classes. They don't seem, to me, to be in alignment with the descriptions above.
 - All of the footnote references need to be looked at again, and possibly clarified.

Recommendation for the 2025-26 and 2026-27 academic years as Temporary Solution to the Removal of English 20/20M Courses.

- The proposed two-year time period was a concern. It was felt that it should be one semester and the issue be fixed by the spring.
- Concern was expressed that students may be confused as to where this is coming from.
- Why not say waive English 20?
- This would increase the workload of WPJ and English 20.
- Context was provided as to why the decision was made from the Interim Dean of the College of Arts and Letters.
