COMMITTEE OF THE WHOLE: Senators and guests engaged in a discussion on what the Senate can do to better support students (and the greater campus community) during the Palestine/Israel conflict. Some of the suggestions offered were:

- Hosting or promoting teach-ins/townhalls and/or providing safe spaces for conversations
- Asking the Administration to bring to the campus additional counselors on a short-term basis to deal with the added mental health challenges the conflict is creating in the campus community.
- Issuing a SacSend message to let the faculty know that they should be extra flexible and understanding with students in terms of late assignments, make-up work, etc.
- Consider implementing a grading structure (similar to when the campus was dealing with the
 effects of the COVID pandemic) that allows students to opt to have a letter grade converted to
 a CR/NC grade.
- Adopting a Senate resolution calling for a cease fire (or some other resolution).
