The Faculty Senate approves the amendments to the Standing Rules, Article III. Conduct of the Faculty Senate Business, C. Time Setting, Procedures for Orderly Debate, and Adjournment, 5. Voting

Voting on Senate business shall typically take place by means of a ~~voice vote or~~ show of hands. A call for ~~a paper ballot or the use of clickers (or other electronic vote registering devices)~~ an electronic vote may be made by an individual Senator; its adoption requires approval by a simple majority vote. A roll call vote may be ordered by a vote of one-fifth (20%) of the representatives present and voting.
