Voting on Senate business shall typically take place by means of a voice vote or show of hands. A call for a paper ballot or the use of clickers (or other electronic vote registering devices) an electronic vote may be made by an individual Senator; its adoption requires approval by a simple majority vote. A roll call vote may be ordered by a vote of one-fifth (20%) of the representatives present and voting.
