<u>Drop & Withdrawal Policy</u> – according to this policy an instructor can *refuse* to allow a student to drop or withdraw from a course. The policy also has binary pronouns that need to be changed. Gonzalez will address with senate executive.

UARTP policies – the classification of performance ratings is very inconsistent across colleges/departments. Gonzalez can take to UARTP.

Graduation and 85 units – is there a reason that it can't be 80 units? Faul and Salcido will discuss with Registrar

Is there an exception to 120 units, meaning can a student request an exception to graduate with 119 units – no, there is no exception. They can take a 1-unit elective at a community college or a one unit independent study (e.g., 199) but there is not exception, a student must have completed 120 units to graduate.

According to EO 1037 a student can only have 18 withdraw units.

5. Agenda Items

a. Grading Policy

Continued discussion about the addition of the A+ grading system. ASI does not currently support the proposal as the grade point average (GPA) units do not differ between an A and an A+. Transcripts indicate what the grading system at Sac State is so no student should be expected to earn an A+ however, many graduate school programs do not look at GPA and expect to see an A+ grading system or an A+ grade (students with A+ may have more/different opportunities than students that are only offered an A grading system). Other CSUs use the A+ grading system (in addition to UCs and other reputable colleges and universities). Faculty will not be *required* to use the A+ grading system.

Consensus was not met – Gonzalez noted that a vote will need to occur at next meeting.

Graduate student grades – Gonzalez will reach out to Newsome to discuss
