Open Forum:

Sacramento State Branding: Questions were raised regarding the use of University name, in particular information on business cards. The Chair was asked to speak to the President. Bowie will speak with the President regarding a conversation when the President next meets with Exec.

Faculty Representatives to Committees (Search, Task Force, Work Groups): There was a suggestion to include statements and not to exceed 200 words, but no decision was taken and there was not strong support for the idea.

From the Chair:

- Background Check Policy Update: There are many questions around the new policy which the Chancellor's Office is working on. VP Lovely will speak with Exec in mid-October once she has more information from the Chancellor's Office. Academic Senator Miller reported that the Academic Senate is reviewing the policy.
- **UARTP Committee Membership:** Exec was advised of attendance issues with a Committee member. Per Senate policy, the Exec directed the Senate Chair to contact the College Dean regarding the faculty member's status and then notify the member that the position is considered vacant. The process for filling the vacancy will then be completed with the College.
