For the 2025-2026 catalog all course and program changes must be approved by all appropriate bodies (Curriculum Subcommittee, GE Course Review Subcommittee, Graduate Studies Policies Committee, Senate Executive, full Faculty Senate, and the President) no later than **February 6, 2026**. The publication date for the 2026-2027 catalog is April 7, 2026. Also noted are the deadlines by which experimental courses must be submitted by the college for approval prior to the registration period.
