- This form is only for proficiency testing in all other languages other than Spanish to fulfill the California State University, Sacramento Foreign Language Graduation Requirement (FLGR). Fulfilling the FLGR through testing does not award academic units toward graduation in any way. The Spanish Proficiency Test (SPT) is offered by the Department of World Languages & Literatures and requires a different test available on our website at <u>www.csus.edu/wll</u>.
- Language proficiency testing is performed on an individual basis with an authorized examiner to be conducted in an interviewstyle format. A list of recommended evaluators is available on our website. If and when you are evaluated, it is important to stay at least 6 feet away from other people and wear a cloth face covering to slow the spread of COVID-19. It is recommended to use video chat such as Zoom, Skype or Google Hangouts to complete the evaluation. Keep a safe distance to slow the spread.
- No fee is required through this department. However, faculty or examiners outside the department may elect to charge a fee. Students are encouraged to verify any fees in advance of their evaluation appointment.

It is the sole responsibility of the student to contact an evaluator and verify their credentials. A list of recommended and approved evaluators including the evaluation form can be found in the office of the Department of World Languages & Literatures (WLL) in Mariposa Hall 2051 and on our website.

The Test

In order to fulfill the **FLGR** for Sac State, the **student must successfully complete at least two of the following skills**: speaking proficiency, reading proficiency, writing proficiency and listening comprehension – **with one skill in either reading or writing**. Testing is performed on an individual basis with an authorized examiner to be conducted in an interview-style format. **This test may only be taken once.**

No fee is required through this department. However, faculty or examiners outside the department may elect to charge a fee. Students are encouraged to verify any fees in advance of their evaluation appointment. Once this form is submitted to WLL the results will be sent to Degree Evaluations in the office of the Registrar. Please allow 4 to 6 weeks for processing by the Registrar.

If and when you are evaluated, it is important to stay at least 6 feet away from other people and wear a cloth face covering to slow the spread of COVID-19. It is recommended to use video chat such as Zoom, Skype or Google Hangouts to complete the evaluation. Keep a safe distance to slow the spread.

Qualifications for Evaluators

If the evaluator is located within the World Languages & Literatures Department or is employed by the university or its affiliates, then the completed evaluation form is the only documentation necessary for submission.

If the evaluator is not included on the WLL list of recommended and approved evaluators, they must provide a written statement to be printed on company, agency or institutional letterhead briefly describing their qualifications as well as which skills were tested and an overall assessment. The evaluator's contact information must be accurate and up-to-date in the event that the University Registrar chooses to contact them for verification or clarification – this responsibility lies solely with the student. It is recommended that your evaluator has some experience teaching and/or is completely fluent in speaking, reading and writing the language to be evaluated.
