Student Eligibility/Qualifications

In order to participate in the Internship/Cooperative Education Program, students must meet ALL of the following requirements PRIOR to enrolling in the program.

Undergraduate [Bachelor's] students:

○ Major	Must be declared Business Administration major [Pre-Business does not qualify]
○ GPA	Undergrads must have a minimum GPA of 2.5 MIS and ACCY students must have a minimum GPA of 2.75
○ Class standing	Be at least a second semester junior
○ Completion of Units	Must have completed 75 units with at least 15 upper-division units in the CBA prior to entering the Internship/Co-Op Program. These courses must have a course number of 100 or higher. Notes: <ul style="list-style-type: none"> ○ MIS students must have completed MIS 160 for Internship ○ ACCY students must have completed ACCY 111 for either a Co-Op or Internship ○ HROB students must have completed HROB 151 for a Co-Op course ○ RELU students must have completed RELU 19, 142, 145 for Co-Op
○ WPJ	Must have completed the WPJ prior to enrolling in an Internship or Co-Op

Graduate [Master's] Student Requirements

○ Major	Must be declared Master's of Business Administration major [Pre-Master's in Business Administration does not qualify]
○ GPA	Graduate students must have a minimum GPA of 3.0
○ Foundation	Must have completed the foundation coursework
○ Completion of Units	Must have completed 6 units [2 core courses] of the program requirements – these courses must begin with a course number of 210 or higher MIS 210 must be completed for a Co-Op MSBA-MIS students must have completed two of the following: MIS 240, 260 250, 270 for the Internship.
○ Writing Proficiency	Must have completed the Writing proficiency requirements for graduate students: Either the WPE or approved exemption PRIOR to enrolling in an internship or Co-op.
