### University Curriculum Approval Deadlines for the 2022-2023 AY

The approval deadlines for course and program proposals for the **2022-2023 AY** are listed below. Program and course change proposals that are not approved by the catalog deadline will be implemented in the following catalog year. For the 2023-2024 catalog all course and program changes must be approved by all appropriate bodies (Curriculum Subcommittee, GE Course Review Subcommittee, Graduate Studies Policies Committee, Senate Executive, full Faculty Senate, and the President) no later than **February 10, 2023**. The publication date for the 2023-2024 catalog is March 2023. Also noted are the deadlines by which experimental courses must be submitted for approval prior to the registration period.
