Step 2: Registration Process

Obtain the [Summer Session Registration Form](#), fill out completely and email your form to coe-cred@csus.edu with the subject title **“Summer 2024 Registration Form.”** One of our College of Education (COE) staff members will obtain the instructor/chair signature and email the form back to you.

Once you have the signed summer registration form, you will need to email it to the College of Continuing Education (CCE) ccecreditreg@csus.edu **beginning Wednesday, May 1st**. A CCE team member will process the forms as they come in and then they will reach out to you for payment. Your initial registration period will be May 1st to May 24th; if you miss the initial registration period you will have another opportunity on May 28th to complete the registration process.

PLEASE NOTE: Registration forms, with signatures and fee payment, must be emailed to the College of Continuing Education no later than 5:00pm on FRIDAY, MAY 24th to confirm your spot in the course. We have reserved a limited number of seats for Credential candidates but it is on a first come basis. Once we have reached our cap – there is no guarantee that you will be added.

****If you have applied for summer financial aid, your eligibility won't be determined until mid-summer. If you qualify for aid, you will receive partial or full reimbursement of registration fees later this summer.**
