### Step 2: Registration Process

Obtain the <u>Summer Session Registration Form</u>, fill out completely and email your form to <u>coe-cred@csus.edu</u> with the subject title **"Summer 2025 Registration Form."** One of our College of Education (COE) staff members will obtain the instructor/chair signature and email the form back to you.

Once you have the signed summer registration form, you will need to email it to the College of Continuing Education (CCE) <u>ccecreditreg@csus.edu</u> **beginning Wednesday, May 7<sup>th</sup>.** A CCE team member will process the forms as they come in and then they will reach out to you for payment. Your initial registration period will be May 7<sup>th</sup> to May 23<sup>rd</sup>; if you miss the initial registration period you will have another opportunity on May 27<sup>th</sup> to complete the registration process.

PLEASE NOTE: Registration forms, with signatures and fee payment, must be emailed to the College of Continuing Education <u>no later than 5:00pm on FRIDAY, MAY 23<sup>rd</sup> to confirm your spot in the course</u>. We have reserved a limited number of seats for Credential candidates, but it is on a first-come basis. Once we have reached our cap – there is no guarantee that you will be added.

\*\*If you have applied for summer financial aid, your eligibility won't be determined until mid-summer. If you qualify for aid, you will receive partial or full reimbursement of registration fees later this summer.
